### **School Fees**

- Application Fee: \$25 per new student will apply
- Registration Fee: \$215 per new family; Current families will have \$200 of their \$215 re-enrollment fee applied to their 2024-2025 Tuition
- Book & Material Fee: \$250 will apply per child
- Graduation Fee: \$150 will apply for all enrolled 8th-grade students
- Sibling Discount: A \$500 sibling discount is applied to 2 or more students enrolled at St. Joe's or Trinity High School at the same time
- NEW! Active Duty Military Member \$2,500 discount and a Veterans Discount \$1,000
- Fair Share Calendars: \$100 per student

## **Payment Options**

St. Joseph Regional Junior High School is committed to ensuring Catholic education is affordable and accessible to all families seeking it.

The School accepts yearly, quarterly, monthly, biweekly, or weekly tuition payments. Please get in touch with the Business office; we are happy to help you set these options up.

FACTS Tuition Management is our chosen vehicle for all tuition payments.

All families must sign up for and maintain a FACTS account to manage payments to the School.

## **Enrollment Terms for the 2024-2025 Academic year**

I/We intend to enroll a child at St. Joseph Regional Junior High School ("School") for the 2024-2025 Academic Year. I/We understand the following:

I/We intend to enroll a child at St. Joseph Regional Junior High School ("School") for the 2024-2025 Academic Year. I/We understand the following:

Parents pay Tuition and fees in one of three ways: (1) in full no later than July 1, (2) semiannual plan via FACTS, or (3) every month via the FACTS monthly payment plan over eleven months.

Please refer to the attached Tuition and fees schedule:

- I/we must maintain a current FACTS agreement
- My/our obligation to pay the fees and Tuition for the entire academic year is unconditional. If I withdraw a child from School, I/we am/are responsible for the remaining tuition costs according to the following schedule:

Withdrawal Date \*Obligation

July 1, 2024 - August 31, 2023 20% of tuition & fees

September 1, 2024 - October 31, 2023 50% of tuition & fees

November 1, 2024 – December 31, 2023 80% of tuition & fees

After January 1, 2025, 100% of tuition & fees

The obligation to the School is calculated on the subtotaled family tuition found on the Tuition & Fees schedule. All prepaid tuition discounts, financial aid, scholarship awards, and registration fee prepayment are nullified when calculating the amount owed to the School.

- St. Joseph Regional Junior High School will not refund Tuition and fees paid in advance
- Student Fees and Tuition outstanding from the prior academic year must be resolved before re-enrollment. No student will be permitted to take final examinations, and grades will be marked as "Incomplete" until the student's account has been paid in full.
- Unpaid Accounts will result in a non-registration for the following school year. Students will not be permitted to begin classes until all tuition payments due to date for the current and previous years have been made.
- Student past-due accounts will be handled in the following manner:
  1. Any parent/guardian whose account is 30 days past due will be asked to meet with the Business Manager to discuss a payment schedule agreeable to the School.
  2. Any account that is 60 days past due may result in the student not being allowed back to class until repayment plans have been made. I/we agree to fulfill all financial obligations by the required due dates.
- I/we will pay any bank fee incurred by the School for any check I/we write to the School. Late fees for tuition payments will be assessed through FACTS.
- The School believes that a positive and constructive working partnership between the School and the student's parents (or guardian) is essential to fulfilling the School's mission. Therefore, the School reserves the right to discontinue enrollment, withdraw an offer of enrollment or re-enrollment, and place restrictions on my or other family members' involvement or activity at School, on School property, or at school-related events if the School concludes that the actions do not allow for a positive and constructive relationship with School. The decision of the School in these matters shall be final.
- If an outstanding balance is unpaid, the School may terminate the student's enrollment and initiate collection proceedings. If collection proceedings are initiated, I/we understand and agree. I/we will reimburse the School for all costs, expenses, interest, and fees incurred by the School in connection with any proceeding to collect an unpaid balance, including but not limited to attorneys' fees, collection agency fees, and court costs.
