#### 1. DETERMINE YOUR TAX LIABILITY AND CONTRIBUTION AMOUNT

Estimate your New Hampshire BPT,BET liability, or I & D for the year. Determine the amount of this liability you would like to contribute to CSF.

2. DOWNLOAD THE APPLICATION: NH.SCHOLARSHIPFUND.ORG/SUPPORT Mail your completed Education Tax Credit Application (Form ED-02) to the New Hampshire Department of Revenue Administration (NHDRA).

#### 3. SEND CONTRIBUTION TO CSF **WITHIN 60 DAYS.**

Once approved, send your contribution via mail to Children's Scholarship Fund NH, 89 State Street, Concord, NH within 60 days.

# **Increase Student Opportunities**

The NH Education Tax Credit program offers a transformational opportunity for **Diocese of Manchester Catholic School** students through tax credit scholarships. New Hampshire children coming from public schools from low-income families have access to new scholarships to attend non-public schools. Tax credit scholarships could cover up to 75 percent of tuition for students starting in the 2019-2020 school year. Scholarship eligibility is based on a family's income. For example, a student could receive a scholarship if his/her family income is less than 300% of the poverty guidelines.

### **Lower Your Tax Bill**

The NH Education Tax Credit program provides tax credits to businesses and individuals that contribute money to Children's Scholarship Fund NH (CSF NH), which is an approved Scholarship Granting Organization. CSF NH awards scholarships to eligible students from low-income families. Businesses and individuals can receive a credit against their NH state taxes, Business Enterprise Tax, Business Profits Tax, or Interest and Dividends Tax equal to 85 percent of their donation.



## Do I qualify?

- → Eligible children must be New Hampshire residents between the ages of 5 and 20 and entering Kindergarten or first grade for the first time OR entering 2-12th grades and coming from a public school (SASID is required)
- → Scholarships are awarded based on the metrics in the education tax credit law until funding is exhausted. Awards will vary based on your family's income, household size, and the school's tuition cost. Non-CSF financial aid will also be considered.

## How do I apply?

→ The first step: visit nh.scholarshipfund.org/apply to complete an online pre-application to determine your eligibility and enter your contact information. If eligible, you will be invited by email to submit a full application online.
