School Fees

- Application Fee of \$25 per student will apply
- Registration Fee of \$215 will be due once a student has been accepted to school.
- Book & Material Fee of \$250 will apply per child
- Graduation fee of \$150 will apply for all enrolled 8th grade students
- There will be a \$500 sibling discount applied to 2 or more students enrolled at St. Joe's at the same time.
- Fundraising Obligation-\$250 per family

Families will have **2 options** to help bridge the gap between tuition and the actual cost to educate their child. **OPT. 1-** Families can pay the \$250 fundraising buyout by the first day of school.

Families that choose this option are not eligible for the same fundraising incentives unless they do additional fundraising or **OPT. 2-** Families can participate in 3 fundraisers that the school will run during the school year. Money collected will be credited to Walk-a thon Pledges (80%), Lottery Calendars (80%) and Spring Raffle Tickets (80%).

Payment Options

St. Joseph Regional Junior High School is committed to ensuring Catholic education is affordable and accessible to all families that are seeking it.

The school accepts yearly, quarterly, monthly, biweekly, or weekly tuition payments. Please reach out to the Business office and we are happy to help you set these options up.

FACTS Tuition Management is our chosen vehicle for all tuition payments.

All families will need to sign up for and maintain a FACTS account to manage payments to the school.

Enrollment Terms

I/We intend to enroll a child at St. Joseph Regional Junior High School ("School") for the 2023-24 Academic Year. I/We understand the following:

- Tuition and fees may be paid in one of three ways: (1) in full no later than July 1, (2) semiannual plan via FACTS, or (3) on a monthly basis via the FACTS monthly payment plan over eleven months.

Please refer to the attached tuition & Fees.

- I/we must maintain a current FACTS agreement
- My/our obligation to pay the fees and tuition for the full academic year is unconditional. If I withdraw a child from school, I/we am/are responsible for remaining tuition costs according to the following schedule:

Withdrawal Date *Obligation

July 1, 2023 - August 31, 2023 20%

September 1, 2023 - October 31, 2023 50%

November 1, 2023 – December 31, 2023 80%

After January 1, 2024 100%

The obligation to the school is calculated on the subtotaled family tuition found on the Tuition & Fees schedule. All prepaid tuition discounts, financial aid, scholarship awards, and registration fee prepayment are nullified when calculating the amount owed to the school.

- Tuition and fees paid in advance cannot be refunded
- Fees and tuition outstanding from the prior academic year must be resolved before re-enrollment. No student will be permitted to take final examinations and grades will be marked as "Incomplete" until the account has been paid in full.
- Unpaid Accounts will result in a non-registration for the following school year. Students will not be permitted to begin classes until all tuition payments due to date for the current and previous years have been made.
- Past Due Accounts will be handled in the following manner:
 - Any parent/guardian whose account is 30 days past due will be asked to meet with the Business Manager to discuss a payment schedule agreeable to the school.
- o Any account which is 60 days past due may result in the student not being allowed back to class until repayment plans have been made. I/we agree to fulfill all financial obligations by the required due dates.
- I/we will pay any bank fee incurred by the school for any check I/we write to school. Late fees for tuition payments will be assessed through FACTS.
- School believes that a positive and constructive working partnership between school and student's parents (or guardian) is essential to the fulfillment of the school's mission. Therefore, school reserves the right to discontinue enrollment, withdraw an offer of enrollment or re-enrollment, and place restrictions on my or other family members' involvement or activity at School, on School property, or at school-related events, if school concludes that the actions do not allow for a positive and constructive relationship with School. The decision of the school in these matters shall be final.
- If an outstanding balance is unpaid, the school may terminate enrollment of the student and/or initiate collection proceedings. If collection proceedings are initiated, I/we understand and agree and I/we will

reimburse school for all costs, expenses, interest, and fees incurred by school in connection with any proceeding to collect an unpaid balance, including but not limited to attorneys' fees, collection agency fees, and court costs.

- I/we agree to allow my child's photograph, image, and voice to be used by St. Joseph Regional Junior High School in publications, promotional materials, and via the website without compensation and without prior notice.
